


## Disposable Wrist Strap


## **Data Sheet**

The 3M 2209 Disposable Wrist Strap provides costeffective and reliable static protection for less than a dollar. The wrist strap is ideally suited for shipment along with components to ensure protection at the receiving end, or for short-term use in the plant for visitors and others who don't need the durability of a reusable strap.

A hypo-allergenic adhesive provides 360 degree contact with the skin to minimize skin-to-band resistance. At the other end, the conductive adhesive on the copper foil adheres to any convenient electrical ground. A current limiting resistance is fabricated into the plastic ribbon below the wrist band.

Each Model 2209 is individually packaged in a clear poly envelope. Custom printing on a paper envelope is available by special order.

## Warning:

A one megohm resistor is located in 3M Wrist Strap Ground Cords. DO NOT REMOVE. If it becomes damaged, replace ground cord immediately. These products are not to be used in areas where the individual may come in contact with electrical circuitry exceeding 250 volts.

These products are for static control. They will not reduce or increase your risk of receiving electrical shock when using or working on electrical equipment. Follow the same precautions you would use without wrist straps, including:

- Make certain that equipment having a grounding type plug is properly grounded.
- Make certain that you are not in contact with grounded objects other than through the 3M Wrist Strap.

90 Day Warranty – 3M expressly warrants that for a period of ninety (90) days from the date of purchase, Series 2045/50 Shoe Straps, 2209 Disposable Wrist Straps, 9250 Keyboard Strips, 3M Flexible Packaging, and 7100/7200 Series Labels will be free of defects in materials (parts) and workmanship (labor). Defects occurring during the warranty period will be repaired or products will be replaced at 3M's option and expense, if 3M receives notice during the warranty period. Defective products must be returned to 3M with proof of purchase date.
